Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Provincial Government of Cavite now invites bids for the **Supply and Delivery of Medical and Laboratory Supplies for use of KPFP-Extension**. Delivery of the Goods is required within Thirty (30) Calendar days upon receipt of Notice of Award.
