2. The Provincial Government of Cavite now invites bids for the **Supply and Delivery of Medical Supplies for Blood Bank Department of PHO**. Delivery of the Goods is required within Thirty (30) Calendar days upon receipt of Notice of Award. Bidders should have completed, within the last Two (2) years from the date of submission and receipt of bids, a contract similar to the Project.
