The **Provincial Government of Cavite**, through its 20% Development Fund for CY 2017 approved by the Sangguniang Panlalawigan, intends to apply the sum of **One Million Six Hundred Fifty Thousand Pesos (P1,650,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of Medical Equipment to be used in Gen. Emilio Aguinaldo Memorial Hospital (Anesthesia Machine w/ Monitor)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Provincial Government of Cavite now invites bids for the **Supply and Delivery of Medical Equipment to be used in Gen. Emilio Aguinaldo Memorial Hospital Anesthesia Machine w/ Monitor**. Delivery of the Goods is required within Thirty (30) Calendar days upon receipt of Notice of Award. Bidders should have completed, within the last Two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
