## **RESOLUTION NO. 621**

A RESOLUTION AUTHORIZING HON. JESUS CRISPIN C. REMULLA, PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH NINE (9) PRIVATE MEDICAL CONSULTANTS WHOSE COMPETENCY AND EXPERTISE WERE CAREFULLY ASCERTAINED BY THE PHILIPPINE HEALTH OFFICE

**WHEREAS**, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Jesus Crispin C. Remulla, Provincial Governor;

WHEREAS, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, Section 3(b) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that there shall be established in every local government unit an accountable, efficient, and dynamic organizational structure and operating mechanism that will meet the priority needs and service requirements of its communities;

WHEREAS, Section 3(I) of the same Act provides that the participation of the private sector in local governance, particularly in the delivery of basic services, shall be encouraged to ensure the viability of local autonomy as an alternative strategy for sustainable development;

WHEREAS, said private medical consultants are expected to contribute to the excellent delivery of health services among Caviteños;

NOW, THEREFORE, on motion of Hon. Nato and Hon. Salazar, duly seconded by Hon. Gawaran and all the members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that Hon. Jesus Crispin C. Remulla, Provincial Governor, be authorized, for and on behalf of the Provincial Government of Cavite, to enter into and sign the Memorandum of Agreement with nine (9) private medical consultants whose competency and expertise were carefully ascertained by the Philippine Health Office.
