Section 1. Supplemental Budget No. 3 for Fiscal Year 2016 of the Provincial Government Of Cavite, amounting to Two Million One Hundred Thousand Pesos (P2,100,000.00), is hereby approved.

Section 2. The amount of One Million Three Hundred Fifty Thousand Pesos (Php1,350,000.00) appropriation for Maintenance and Other Operating Expenses of the Office of the Provincial Governor and Seven Hundred Fifty Thousand Pesos (P750,000.00) appropriation for Capability Development Program of the Special Purpose Appropriation, be realigned for the purpose;

Section 3. This Appropriation Ordinance shall take effect immediately after its approval.

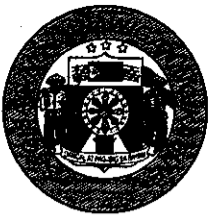


