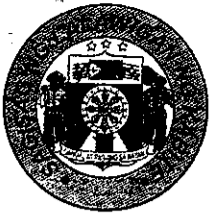

SECTION 1. The positions of Administrative Aide IV (Stenographer I), Salary Grade 4, and Administrative Aide VI (Clerk III), Salary Grade 6, with Item No. 31 and Item No. 34 respectively, in the Office of the Provincial Governor (Personal Staff), is hereby reverted from primarily confidential to career position.

SECTION 2. This ordinance takes effect immediately.
