**WHEREAS**, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is Committee Report No. 078, submitted by Hon. Teofilo B. 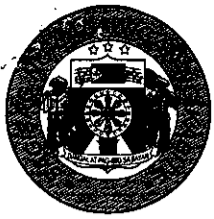




