A RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 06 FROM THE CITY OF DASMARIÑAS, AMOUNTING TO ONE HUNDRED ELEVEN MILLION SEVEN HUNDRED SEVEN THOUSAND TWO HUNDRED EIGHTEEN PESOS AND TWELVE CENTAVOS (PHP111,707,218.12)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is Committee Report No. 006-2016, submitted by Hon. Ivee Jayne A. Reyes, Chairperson, Committee on Finance, Budget, and Appropriations, pertaining to a resolution from the City of Dasmariñas, entitled:

Resolution No. 242-S-2015 — Resolution Approving The Amount Of One Hundred Eleven Million Seven Hundred Seven Thousand Two Hundred Eighteen Pesos And 12/100 (Php111,707,218.12) As Supplemental Budget No. 06 For The General Fund Of The City Of Dasmariñas, Cavite

- Utilization of savings certified available by the City Treasurer shall be subject to the condition that the same remain free of any obligation or encumbrances and/or are still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriations were originally authorized;
- The grant of the FY 2015 Productivity Enhancement Incentive (PEI) to government employees shall strictly be in accordance with the guidelines prescribed in Executive Order No. 181 dated May 15, 2015;
- The payment of Monetization of Leave Credits shall be in accordance with the guidelines prescribed in CSC-DBM Joint Circular No. 2-97 and Budget Circular No. 2002-1;
- The disbursement of all other appropriations shall be subject to the usual accounting and auditing rules and regulations.

NOW, THEREFORE, on motion of Hon. Reyes, duly seconded by Hon. Grepo and all the members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that Supplemental Budget No. 06 from the City of Dasmariñas, amounting to One Hundred Eleven Million Seven Hundred Seven Thousand Two Hundred Eighteen Pesos And Twelve Centavos (Php111,707,218.12), be approved.
