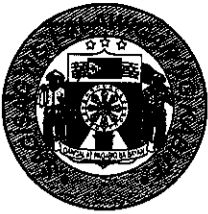
RESOLUTION NO. 458

A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO ENTER INTO AND SIGN THE MEMORANDUM OF UNDERSTANDING WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND THE CITY GOVERNMENT OF IMUS FOR THE IMPLEMENTATION OF THE FLOOD RISK MANAGEMENT PROJECT-IMUS RIVER COMPONENT

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Juanito Victor C. Remulla Jr., Provincial Governor;

WHEREAS, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, the entire country is often sunk to the aftermath of calamities and has long been enduring flood caused by typhoons and other catastrophes brought by climate change;

WHEREAS, the DPWH, with its mandate to plan and develop reliable infrastructure system in the country, the local government units, in its commitment to protect the welfare of its constituents, and the Provincial Government of Cavite with its purpose and oath to provide full assistance to its component local government units, are conspiring to create effective means to alleviate or evade flood and other predicaments connected to it;

WHEREAS, the tendencies of the Imus River to overflow due to heavy rainfall was realized and is being addressed before it could harm more people and properties;

WHEREAS, the overall objective of the project is to achieve effective implementation and management of flood control projects and the preservation of the same to sustainable operating conditions;

NOW, THEREFORE, on motion of Hon. Enriquez and Hon. Cantimbuhan, duly seconded by Hon. Mangubat and all the members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that Hon. Juanito Victor C. Remulla, Jr., Provincial Governor, be authorized, for and on behalf of the Provincial Government of Cavite, to enter into and sign the Memorandum of Understanding with the Department of Public Works and Highways and the City Government of Imus for the implementation of the Flood Risk Management Project-Imus River Component.
