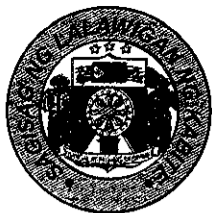

A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA, JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE (PGC), TO NEGOTIATE AND CONTRACT WITH ANY QUALIFIED BANKING INSTITUTION FOR THE CONSTRUCTION/ESTABLISHMENT OF A GOVERNMENT CENTER IN BARANGAY LALAN, SILANG, CAVITE IN THE AMOUNT OF SEVEN HUNDRED MILLION PESOS (PHP700,000,000.00)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Juanito Victor C. Remulla Jr., Provincial Governor;

WHEREAS, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, Section 11 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that when conditions and developments in the local government unit concerned have significantly changed, the seat of government may be transferred to a better site, taking into consideration the geographical centrality, availability of transportation and communication facilities, development and economic progress, and other relevant considerations;

WHEREAS, the PGC needs financial back-up in order to establish the building which will preserve its integrity and envisage new aspirations for its employees and for all the people of Cavite;

NOW, THEREFORE, on motion of Hon. Lara and Hon. Reyes, duly seconded by Hon. Grepo and all the members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that Hon. Juanito Victor C. Remulla, Jr., Provincial Governor, for and on behalf of the Provincial Government of Cavite, be authorized to negotiate and contract with any qualified banking institution for the construction/establishment of a government center in Barangay Lalaan, Silang, Cavite in the amount of Seven Hundred Million Pesos (Php700,000,000.00).
