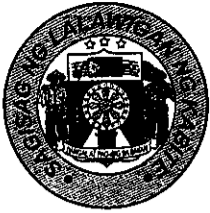
A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA, JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE BOTIKA NG LALAWIGAN NG CAVITE (BLC), TO ENTER INTO DRUG CONSIGNMENT AGREEMENTS WITH SEVERAL DRUG CONSIGNORS
