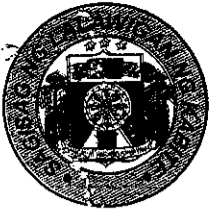


**NOW, THEREFORE**, on motion of Hon. Lara, duly seconded by Hon. Grepo and all the members present, be it
