RESOLUTION NO. 574

A RESOLUTION AUTHORIZING HON. JESUS CRISPIN C. REMULLA, PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO PURCHASE A PARCEL OF LAND (280 SQUARE METERS) FOR THE ESTABLISHMENT OF A MULTI-PURPOSE HALL IN BARANGAY PANUNGYAN I, MENDEZ-NUÑEZ, CAVITE

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Jesus Crispin C. Remulla, Provincial Governor;

WHEREAS, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, the land to be purchased is 280 square meters which is covered by Tax Declaration Nos. 14-0023-00230, 14-0023-00231, 14-0023-00234, and 14-0023-00229 in the amount of One Thousand Five Hundred Pesos (Php1,500.00) per square meter or a total amount of Four Hundred Twenty Thousand Pesos (Php420,000.00);
