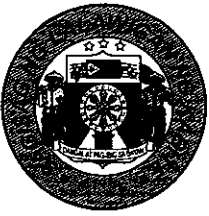
RESOLUTION NO. 593

A RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 5, SERIES OF 2016, FROM THE CITY OF BACOR, AMOUNTING TO SEVENTY-SEVEN MILLION NINE HUNDRED FORTY THOUSAND PESOS (PHP77,940,000.00)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is an ordinance from the City of Bacoor, titled:

Appropriation Ordinance No. CO 50-S-2016 – An Ordinance Authorizing Supplemental Budget No. 5, Series of 2016 Involving An Amount Of Seventy Seven Million Nine Hundred Forty Thousand Pesos (Php77,940,000.00) For Current Operating Expenditures And Capital Outlay Of The City Government Of Bacoor For Fiscal Year 2016
