A RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 03 FROM THE CITY OF GENERAL TRIAS, AMOUNTING TO ONE HUNDRED SEVENTY-EIGHT MILLION SEVEN HUNDRED FIFTY THOUSAND PESOS (PHP178,750,000.00)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is Committee Report No. 118, submitted by Hon. Homer T. Saquilayan, Chairperson, Committee on Finance, Budget, and Appropriations, pertaining to an ordinance from the City of General Trias, titled:

City Ordinance No. 16-08 – Appropriating The Sum Of One Hundred Seventy Eight Million Seven Hundred Fifty Thousand Pesos (Php 178,750,000.00) To Be Taken From The Savings In General Fund Surplus 2015 Under The General Fund Allocation And Purchase Of Rice Sacks And/Or Trash Bags Under The Mayor's Office Allocation To Be Made Available As Supplemental Budget No. 03

1. Utilization of savings certified available by the City Treasurer shall be subject to the condition that the same remain free of any obligation or encumbrances and/or are still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriations were originally authorized;
2. The disbursement of all appropriations shall be strictly subject to existing accounting and auditing rules and regulations;
3. Compliance with all existing laws, rules and regulations relative to the implementation of the within reviewed Supplemental Budget No. 3 of the City Government of General Trias, Cavite shall be the sole responsibility of the local government unit concerned.

NOW, THEREFORE, on motion of Hon. Saquilayan, duly seconded by Hon. Gawaran and all the members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that Supplemental Budget No. 03 from the City of General Trias, amounting to One Hundred Seventy-Eight Million Seven Hundred Fifty Thousand Pesos(Php178,750,000.00), be approved.
