WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan for review and consideration, is a letter from Hon. Jesus Crispin C. Remulla, Provincial Governor;

WHEREAS, the Dra. Olivia Salamanca Memorial District Hospital, located in Cavite City, has been an institution to Caviteños who require quality medical attention for many years and its reconstruction will cater to the continual need to different health services;

WHEREAS, termite infestation is evident on all parts of the building as the hospital has stood for 56 long years and considering that its ceilings and partitions are made of light materials;

WHEREAS, reconstruction is more recommended than repair as restructuring, to be further coordinated with the DOH, is considered due to the limited facilities and constricted areas that are not competent enough to accommodate patients especially with the growing population of the province;
