AN ORDINANCE DECLARING EVERY 3rd SATURDAY OF SEPTEMBER AS RABIES AWARENESS DAY IN THE PROVINCE OF CAVITE

WHEREAS, it is the declared policy of the state to protect and promote the right to health of the people;

WHEREAS, the Anti-Rabies Act of 2007 (RA 9482) requires that the Department of Health and other Local Government Units, along with other organizations shall cause information drive campaign to increase awareness on the effect of rabies and how to prevent it;

WHEREAS, the presence of adequate health education, promotion and advocacy on responsible pet ownership, proper animal bite wound care and treatment protocol would integrate on rabies prevention and control;

WHEREAS, the goal of this program is to mobilize awareness and resources in support of human rabies prevention and anti-rabies control;

NOW THEREFORE, on motion of Hon. Rolando S. Remulla, duly seconded by Hon. Eralin G. Gawaran and all the Members present, be it ordained by the Sangguniang Panlalawigan in session duly assembled that:

Section 1. TITLE – This ordinance shall be known as *“An Ordinance Declaring Every 3rd Saturday Of September as Rabies Awareness Day in the Province of Cavite”*.

Section 2. DECLARATION OF POLICY – It is the policy of the Provincial Government of Cavite to protect and educate Caviteños as a key strategy for a Rabies Free province.

Section 4. CELEBRATION – The yearly event shall be celebrated every 3rd Saturday of the month of September.

Section 5. FUNDING – For effective implementation of the Ordinance, the Provincial Government of Cavite thru the Office of the Provincial Veterinary shall appropriate necessary fund to defray the expenses of the said activity.

Section 6. EFFECTIVITY – This Ordinance shall take effect immediately upon its approval.
