3. Memorandum of Understanding (MOU) between the Provincial Government through Gen. Emilio Aguinaldo Memorial Hospital and Korea-Philippines Friendship Hospital (GEAMH/KPFP), with MedAsia Philippines, Inc., for the provision of hospitalization, medical and surgical and/or treatment, as well as diagnostic procedures and ancillary services

NOW, THEREFORE, after due deliberation on the aforementioned, on motion of Hon. Nato, duly seconded by Hon. Bencito and all the members present, be it


