1. The **Provincial Government of Cavite-Provincial Disposal Committee** hereby invites all interested parties to participate in the public bidding/auction of the hereunder lot on an "AS-IS WHERE-IS" basis as indicated below:
44 units unserviceable vehicles
10 units unserviceable heavy equipment
Minimum Bid Price (Floor Price) = P854,122.00
2. A bidder must bid for the entire lot consisting of all items. Submission of bid on selected items will not be accepted.
3. It is understood that participating bidders have seen and inspected the subject unserviceable properties from **January 3-8, 2019 (excluding Saturday and Sunday) from 8am to 5pm**. A GSO representative will assist the interested bidders on the inspection of the properties.
4. To clarify and/or explain any of the requirements, terms and conditions stipulated in the bid documents, a **Pre-Auction/Pre-Bid Conference shall be held on December 28, 2018 at 3:30 p.m. at the Bids and Awards Office, Provincial Capitol Building, Trece Martires City, Cavite.**
5. A complete set of Bidding Documents/Terms of Reference may be purchased by interested bidders at the Bids and Awards Office, Provincial Capitol Building, Trece Martires City, Cavite, upon payment of non-refundable fee for the Bidding Documents in the amount of **Five Thousand Pesos (P5,000.00)**.
6. The description of an eligible bidder is contained in the Bidding Documents, particularly, Item E, Preparation of Bid in the Terms of Reference.
7. Submission of bids is on or before **January 9, 2019, 3:30 PM** at **2nd Flr. BAC Office, Provincial Capitol Building, Trece Martires City**. All Bids must be accompanied by a bid security/bond in any of the acceptable forms and in the amount stated in the Terms of Reference.
8. Bid opening shall be **January 9, 2019, 4:00 PM** at **2nd Flr., BAC Office, Provincial Capitol Building, Trece Martires City**. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
9. In any case of the above dates is declared a special non-working holiday, it will automatically be reset on the next Schedule of Opening of Bids.
10. Upon determination of the winning bidder, the bid bond shall be considered as partial payment and the difference between such payment and the offer bid price shall be paid in the form of cash, cashier's or manager's check of a reputable bank within the area where the bidding was held. **Full payment shall be made within ten (10) working days from the date of the receipt of Notice of Award.**
11. Should the winning bidder fail to pay the full amount of the bid price within ten (10) working days from the receipt of the Notice of Award, the same shall be deemed cancelled and rendered ineffective. The ten percent (10%) bond deposit shall be forfeited in favor of the Provincial Government of Cavite;
12. Winning bidders are required to remove all item(s) awarded to them within **thirty (30) working days** after receipt of the Release Order.
13. All expenses incidental to the withdrawal of the property shall be borne by the winning bidder.
14. Bid bond of non-winning bidders shall be returned after the winning bidder has been determined.
15. The Provincial Government of Cavite reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
