Invitation to Bid for Improvement of Canal lining with cover (Gen Jose I, Paua St. Villa Amparo and Sarroca Comp) at Bayan Luma IV, City of Imus, Cavite

1. The **Provincial Government of Cavite**, through the CY 2019 **20% Development Fund** (CY 2017 and CY 2018 Continuing Appropriations) intends to apply the sum of **Two Million Seven Hundred Ninety Four Thousand Pesos (₱2,794,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Improvement of Canal lining with cover (Gen Jose I, Paua St. Villa Amparo and Sarroca Comp) at Bayan Luma IV, City of Imus, Cavite**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Provincial Government of Cavite now invites bids for the **Improvement of Canal lining with cover (Gen Jose I, Paua St. Villa Amparo and Sarroca Comp) at Bayan Luma IV, City of Imus, Cavite**. Completion of the Works is required as indicated in the Bid Documents specified in SCC1.16. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from BAC Secretariat and inspect the Bidding Documents at the address given below during Monday to Friday from 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Five Thousand Five Hundred Pesos (₱5,500.00)**.
6. The Provincial Government will hold the Pre-Bid Conference on December 23, 2019 at 9:30 a.m, at BAC Office, 2nd Floor Capitol Building, Trece Martires City, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be delivered to the address below on or before January 16, 2020 at 9:00 a.m at BAC Office, 2nd Floor Capitol Building, Trece Martires City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18;
8. Bids will be opened on **January 16, 2020, at 10:00 a.m**, in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
9. The Provincial Government of Cavite reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
