Chapter IX. Local Administration

ORGANIZATION AND MANAGEMENT

The Provincial Government of Cavite is led by elected personnel and the operation is undertaken and supported by civil servants. The head of the province is the Local Chief Executive, the Governor. The next in rank, the Vice Governor (Presiding Officer) is heading the Legislative Body composed of fourteen (14) Sangguniang Panlalawigan members. It also includes the President of Liga ng mga Barangay, the President of Provincial Sangguniang Kabataan (SK) Federation, and the President of Cavite Councilors' League. All in all, the Legislative body is composed of 18 member legislators.


Provincial administration and operation is performed through the twenty (20) provincial offices that ensure the delivery of services to all sectors of society in the province. In 2010, the provincial government employs a total of 3,912 employees, including the elected positions. This number decreased by 611 that is equivalent to 13.51% decrease. Such status is brought about by the government's saving measures by controlling the hiring of job orders, eliminating those who are non and poor performing employees. A decrease of 10 plantilla positions was observed from 1,522 in 2009 to 1,512 in 2010. 38.65% or 1,512 employees hold permanent plantilla positions, 24.23% holds casual status, 2.53% in Co-terminus status, 0.69% in temporary status, 0.56% or 22 are contractual and 32.85% or 1,285 are job order employees. There are only 19 elected personnel in the provincial government.

The provincial government resorted to hire employees with job order status for job requirement that are not for long term. Examples of this are encoders, utility workers, and security guards, among others. Job Order system does not require the provincial government to give them fringe benefits that other employees enjoy. In one way or another, job orders tend to give savings for the government. Similarly, job orders make it easy for the provincial government to hire specialized personnel, especially those who have highly demanded technical skills and consultancies.

Plantilla holders are those with "items" approved by the Civil Service Commission (CSC). They are also known as the permanent item holders. Permanent position employees are the backbone employees of the provincial operation, thus their existence are required and mandated by law, the Local Government Code and CSC for that matter. Plantilla holders comprise the 38.65% of the total provincial capitol employees.

Casual employees are usually composed of support staffs. There is a total of 24.23% share of casual employees from the total provincial capitol workforce.

REGISTERED VOTERS

The voters are the one who decides on what kind of leaders they want to direct them. They play important roles as direct supporters and beneficiaries of the government programs and development undertakings. Without the concerted effort of the voters, or the people of Cavite, there is a slim chance that a program will succeed.

the year 2010, Cavite has a total of 1,655,552 registered voters. The City of Dasmariñas holds the largest bulk of voters marked at 18.81% of the total voting population. Also a sole district, Bacoor holds the second place with most number of voters at 17.08%. District III (Imus) has the

least number of voters pegged at 153,161 or 9 percent.

A total of 10,632 precincts were established in the 829 barangays province-wide but these precincts were clustered into 4,983.

The top three districts with most number of voters (Districts 4, 2 and 6) are already responsible to the 51.37% of the voting population considering that these three districts are composed only of 6 cities/municipalities. On the other hand, the remaining districts with 17 cities/municipalities have an aggregated 48.63% of the total voting population of the province.

Province of Cavite: as of October 25, 2010


