## RESOLUTION NO. 2016 - 03

A RESOLUTION ENDORSING TO THE SANGGUNIANG PANLALAWIGAN OF CAVITE THE EXECUTIVE-LEGISLATIVE AGENDA (ELA) AND CAPACITY DEVELOPMENT AGENDA (CapDev) 2017-2019 OF THE PROVINCE OF CAVITE FOR ITS APPROVAL

WHEREAS, the Local Government Code of 1991 (Republic Act 7160) stipulates that local government units are mandated to constitute a local development council (LDC) which shall assist in coordinating and setting the direction of the economic and social development efforts within its territorial jurisdiction;

WHEREAS, among the responsibilities of the LDC is to prepare the development programs and projects that are consolidated from the various projects and programs formulated by various stakeholders in the province;

WHEREAS, the Executive-Legislative Agenda (ELA) is an integrated term based plan that contains the major development thrusts and priorities of both the executive and legislative branches towards a common vision for the Province;

**WHEREAS,** the ELA is an instrument that will prioritize responses to multi-stakeholder needs, e.g., programs, projects, activities, legislations and capacity development programs, and put into action local development plans;

WHEREAS, the Capacity Development Agenda (CapDev) serves as the identification of the capacities that need to be strengthened to facilitate the achievement of LGU's performance goals and map out the interventions that must be undertaken;

**WHEREAS**, in pursuit of the incumbent administration's thrust of advocating a *One, Strong and Competitive Cavite*, both the ELA and CapDev would serve as an implementing instrument that would set in motion the program of governance of the Provincial Government.

NOW THEREFORE, based on the premises previously mentioned, and in motion duly seconded, be it

**RESOLVED**, as it is hereby resolved, to endorse to the Sangguniang Panlalawigan of Cavite, for its approval, the **Executive-Legislative Agenda and Capacity Development Agenda 2017-2019** of the Province of Cavite.
