PROVINCIAL ORDINANCE NO. 162

“AN ORDINANCE DECLARING THE MONTH OF APRIL OF EVERY YEAR AS TAX AWARENESS MONTH IN THE PROVINCE OF CAVITE”

Sponsored by: Hon. Ivey Jayne A. Reyes

WHEREAS, Presidential Proclamation No. 812, s. 2005, signed by former President Gloria Macapagal-Arroyo, provides that the observance of Tax Awareness Month will be a step towards promoting, enhancing and instilling national awareness and appreciation of the importance and value of taxes to our society, while at the same time, obtaining the support and commitment of the taxpaying public to help improve the collection;

WHEREAS, Section 129 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that each local government unit shall exercise its power to create its own sources of revenue to levy taxes, fees, and charges;

WHEREAS, increased revenue generation is urgently needed to finance and sustain vital economic and development programs of the government;

WHEREAS, taxes fund key programs, salaries of public servants and other services provided by the government including infrastructures, public transportation, sanitation, legal systems, public safety, education and health systems;

WHEREAS, the public should be aware that their taxes contribute to the economic growth of the country;

NOW, THEREFORE, on motion of Hon. Reyes, duly seconded by Hon. Gawaran and all the members present, be it enacted by the Sangguniang Panlalawigan in session duly assembled that:

Section 1. Short Title. This Ordinance shall be known and cited as "The Tax Awareness Month Ordinance in the Province of Cavite".

Section 2. Purpose. To have massive information and campaign about the importance of paying taxes on time.

Section 3. Celebration. This yearly event shall be observed every month of April.

Section 4. Funding. For the effective implementation of this ordinance, the Provincial Governor of Cavite shall appropriate necessary funds to defray the expenses of this activity.

Section 5. Effectivity. This ordinance shall take effect immediately upon its approval.

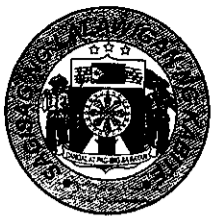


