Section 1. The amount of Six Million Ninety-Two Thousand Four Hundred Thirty-Three Pesos and Twenty-Five Centavos (Php6,092,433.25) for the purchase of medicines and supplies necessary for the conduct of the Provincial Government's medical and dental missions shall be appropriated.
