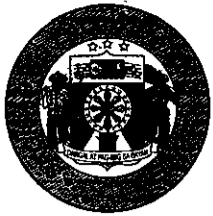
WHEREAS, the activity aims to provide quality medical and dental services and prioritize the poor and underserved communities;

NOW THEREFORE, after due deliberation, on motion of Hon. Crisostomo, duly seconded by Hon. Gawaran and all the members present, be it enacted by the Sangguniang Panlalawigan of Cavite in session duly assembled that:

Section 1. The amount of Five Million Six Hundred Twenty-Seven Thousand Two Hundred Ninety-Six Pesos And Ten Centavos (Php5,627,296.10) for the purchase of medicines and supplies necessary for the conduct of the Provincial Government of Cavite's medical and dental missions shall be appropriated.

Section 2. This appropriation ordinance shall take effect immediately after its approval.

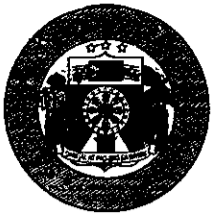




