**APPROPRIATION ORDINANCE NO. 19**

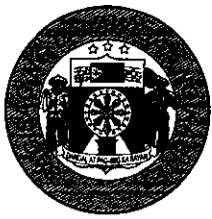
**AN ORDINANCE REALIGNING THE AMOUNT OF SIX MILLION FIVE HUNDRED THOUSAND PESOS (PHP6,500,000.00) FROM SUBSIDY TO LOCAL GOVERNMENT UNITS TO DONATIONS (SCHOLARSHIP)**

**WHEREAS**, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Jesus Crispin C. Remulla, Provincial Governor;

**WHEREAS**, Section 336 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides in part that the Local Chief Executive or the Presiding Officer of the Sangguniang concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations;

**WHEREAS**, an amount of Seven Million Three Hundred Eighty-Four Thousand Three Hundred Thirty-Nine Pesos (Php7,384,339.00) is initially allocated to fund the provincial scholarship program;

**WHEREAS**, an amount of Php6,500,000.00 is needed to be realigned as an additional budget that will benefit deserving students in the province;

**Section 1.** The realignment amounting to Six Million Five Hundred Thousand Pesos (Php6,500,000.00) from Subsidy to Local Government Units to Donations (Scholarship), be approved.

**Section 2.** This Appropriation Ordinance shall take effect immediately after its approval.

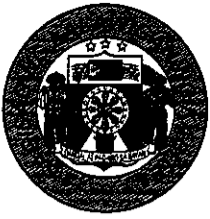
