<b>Provincial Ordinance No. 001-2012:</b>	An ordinance for the Implementation of Anti-Dengue Campaign in Barangay Level
<b>Provincial Ordinance No. 002-2012:</b>	A Provincial Code adopting and pursuing a Public-Private Partnership (PPP) approach towards development, creating a PPP Regulator Authority, and providing appropriations and incentives therefore and for other purposes
<b>Provincial Ordinance No. 003-2012:</b>	An ordinance adopting the Manila Bay Oil Spill Contingency Plan (MBOSCP)
<b>Provincial Ordinance No. 004-2012:</b>	An ordinance requiring all Malls and Recreational Facilities in the Province of Cavite to have First Aid Clinic within their premises
<b>Provincial Ordinance No. 005-2012:</b>	An ordinance mandating the owners/administrators of all health establishments, aerobics and slimmer salons or gyms and body building clubs within the trainers/instructors to undergo training on first aide related courses conducted by Philippine National Red Cross or any government agency concerned as a requirement for hiring or continued employment and providing penalties for violations thereof
<b>Provincial Ordinance No. 006-2012:</b>	An ordinance declaring the first (1st) week of December 2012 and every year thereafter as Government Employees Week in the Province of Cavite
<b>Provincial Ordinance No. 007-2012:</b>	An ordinance prohibiting , regulating and prescribing certain uses of plastics for goods and commodities that end-up as residual wastes and promoting the use of eco-bags and other environment friendly practices as an alternative and providing penalties for violations thereof.
<b>Provincial Ordinances No. 008-2012:</b>	An ordinance authorizing the proposed borrowing of the Province of Cavite in the amount of One Hundred Million Pesos (Php 100,000,000.00) to fund the construction of a three-storey school building with Thirty (30) classrooms in Alfonso and the construction of the Municipal Hall of Indang.
<b>Provincial Ordinance No. 009-2012:</b>	Anti- Trafficking in Persons Ordinance of the Province of Cavite.
<b>Provincial Ordinance No. 010-2012:</b>	An ordinance creating various positions in the Office of the SangguniangPanlalawigan
<b>Provincial Ordinance No. 011-2012:</b>	An ordinance prohibiting animal cruelty and dog fighting activities in the Province of Cavite and adopting the provisions of Republic Act No. 8485, otherwise known as "The Animal Welfare" Act of 1998
<b>Provincial Ordinance No. 012-2012:</b>	An ordinance requiring owners or operators of communication towers and base transceiver stations to secure a certificate or clearance from the Department of Health (DOH) and other concerned agencies on the safety against radiation of residents living within the vicinity of subject towers, transmission line and base transceiver stations subject to all legal and existing rules and regulations
<b>Provincial Ordinance No. 013-2012:</b>	An ordinance providing for free annual medical check-up to employees of the Provincial Government of Cavite from provincially-supervised hospitals within the Province of Cavite
<b>Provincial Ordinance No. 014-2012:</b>	An ordinance creating the position of Supervising Administrative Officer, SG6-22 in the Provincial Assessor's Office
<b>Provincial Ordinance No. 015-2012:</b>	An ordinance amending certain "Provisions of Provincial Ordinance No. 2010-008" An ordinance authorizing the proposed borrowing of the Province of Cavite in the amount of One Hundred Million Pesos (Php 100,000,000.00) to the construction of a three Story School Building with thirty (30) classrooms in Alfonso and the construction of the Municipal Hall of Indang
<b>Provincial Ordinance No. 016-2012:</b>	An ordinance creating the position of Social Welfare Officer I (S6-11) at Dra. Olivia Salamanca Memorial District Hospital
<b>Provincial Ordinance No. 017-2012:</b>	An ordinance adopting the Quality Management System at the Provincial Government of Cavite

<b>Provincial Ordinance No. 018-2012:</b>	An ordinance creating the Cavite Quality Management Office, determining its Composition, Duties and Functions and appropriating funds necessary for the operations thereof
<b>Provincial Ordinance No. 019-2012:</b>	An ordinance reclassifying Administrative Aide VI (Mechanic I) to Reproduction Machine Operator II in General Services Office
<b>Provincial Ordinance No. 020-2012:</b>	An ordinance declaring the 10th Day of October 2012 and every year thereafter as "Barangay Day" in the Province of Cavite
<b>Provincial Ordinance No. 021-2012:</b>	An ordinance abolishing the position of Eight (8) Security Guard I and Two (2) Administrative Aide IV (Co-Terminus Status) and creating the positions of Three (3) Administrative Aide III (Driver I), Six (6) Administrative Aide III (Utility Worker II) and Two (2) Administrative Aide IV (Clerk II), on a Casual Basis in the Cavite Office of Public Safety
<b>Provincial Ordinance No. 022-2012:</b>	An ordinance reverting the position of Administrative Aide VI (Clerk III) - Item No. PS-56 under the Office of the Provincial Sanggunian which was previously declared as primarily confidential in nature to a career classification
<b>Provincial Ordinance No. 023-2012:</b>	An ordinance declaring the 5th Day of October 2012 and every year thereafter as "Cavite Teacher's Day"
<b>Provincial Ordinance No. 024-2012:</b>	An ordinance for the Creation of Cavite Migration Resource Center and appropriate necessary funds thereof and for other purposes
<b>Provincial Ordinance No. 025-2012:</b>	An ordinance for the Creation of the Barangay Population Information Desk and appointing a Barangay Personnel assigned thereof and provide necessary funds for its operation
<b>Provincial Ordinance No. 026-2012:</b>	An ordinance regulating Cigarette Smoking within Provincial Capitol Compound of Cavite and providing penalties thereof
<b>Provincial Ordinance No. 027-2012:</b>	An ordinance confirming the appointment of Ms. Camille Lauren V. Del Rosario, Provincial Government Department Head in the Provincial Information and Communications Technology Office
<b>Provincial Ordinance No. 028-2012:</b>	An ordinance establishing violence against women and their children (vawc) desk in every barangay within territorial jurisdiction of the Province of Cavite
<b>Provincial Ordinance No. 029-2012:</b>	An ordinance changing the name of the Municipality of Gen. E. Aguinaldo to Municipality of Bailen
<b>Provincial Ordinance No. 030-2012:</b>	An ordinance abolishing the position of Accountant I (SG-12) and Accountant II (SG-16) and creating the position of Accountant IV (SG-22) in the Office of the Provincial Accounting
<b>Provincial Ordinance No. 031-2012:</b>	An ordinance for the Creation of One (1) Medical Officer II (SG-21) position in the General Trias Medicare Hospital
<b>Provincial Ordinance No. 032-2012:</b>	An ordinance for the Creation of Eight (8) Regular positions in the Provincial Administrator
<b>Provincial Ordinance No. 033-2012:</b>	An ordinance authorizing Ms. Josephine D. Daza, Provincial Treasurer, the resale of the properties under the name of Diamond Ceramics which were levied by the Provincial Government of Cavite through Public Auction conducted on March 29, 2006
<b>Provincial Ordinance No. 034-2012:</b>	An ordinance declaring first (1st) week of December 2012 and every year thereafter as "LINGGO NG KABATAAN" in the Province of Cavite
<b>Provincial Ordinance No. 035-2012:</b>	An ordinance providing Free Annual Medical Check-up to all Public School Teachers in the Province of Cavite
