## **EXECUTIVE SUMMARY**

This Local Government Report 2014 embodies the holistic account of the state of the Provincial Government of Cavite's (PGC) performance for the fiscal year of 2014. Firstly, it details the accomplishments of each PGC's departments. It gives particulars on the specific activities implemented, its targets and accomplishments, giving the readers a complete grasp of the functions of the each department of the provincial government and their feats. Correspondingly, it also provides each Office's plans and programs for the next fiscal year 2015. This will serve as guide of the PGC in gauging the performance of the entire PGC for the following year.

The Attachment portion provides vital and more in-depth analysis of the accomplishments of the Provincial Government. The Attachment 1 discussed the guiding principles of the Province in terms of its Vision, Missions and Specific Development Strategies. These serve as the influencing direction of all departments in designing their plans and programs. Followed by Attachment 2, the financial performance of the provincial government is described in minutiae. It discusses about provincial revenue, provincial expenditures and income as the budget profile of the province. Various financial statements were also presented showing the very good financial standing of the provincial government. In the Attachment 3, several accomplishments of the provincial government were highlighted. These ventures ranging from local administration, economic and social sector related undertakings are considered to be high impact projects.

Under the Administrative Governance, major accomplishments of the provincial government includes support to national government agencies. The Barangay Health Workers and Barangay Nutrition Scholars were also given support in view of their untiring work for the upliftment of quality of life of Caviteños. Likewise, the Provincial Scholarship Program of the PGC continues to provide assistance to the Caviteño students. The Office of the Governor also prioritizes the health status of the people thru its medical and dental missions. The OPG also spearheads the innovations to become highly competitive thru the Cavite Quality Management Office. Also evident are the efforts of the Finance Committee to improve the financial status of the provincial government resulting to a recognition by the Bureau of Local Government Finance.

Under the Social sector, there are projects implemented to significantly achieve the provincial targets under the Millenium Development Goals. The provincial hospital is continually upgrading to meet the rising demands of the constituents. The security and maintenance of peace were also prioritized thru the empowerment of the Philippine National Police-Cavite and adoption of the Provincial Disaster Risk Reduction and Management Plan of Cavite. There are also housing support programs implemented assisting the homeless Cavitenos.

With regards to Economic Sector, priority projects were implemented to empower the people to become contributors of economic development in the province. Various undertakings were realized relative to job creation, job placements, entrepreneurship and commerce. Being an agricultural province, the agricultural sector was also given importance thru numerous support programs to farmers and agricultural workers.

On the other hand, the Legislative Body provides the best support to the administration by passing significant resolutions and ordinances like continuous innovation on the organizational structure of the provincial government, anti-discrimination ordinance, provision of internet connection to all public high school libraries, revision of the Revenue Code of the Province of Cavite, and Tourism Code, among others.
