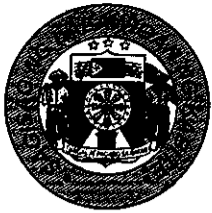

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Juanito Victor C. Remulla Jr., Provincial Governor;

WHEREAS, Section 465 (b)(1)(v) of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall appoint all officials and employees whose salaries and wages are wholly or mainly paid out of provincial funds and whose appointments are not otherwise provided in the Code, as well as those he may be authorized by law to appoint;

WHEREAS, the Provincial Budget Office certifies that the creation of the position is within the Personal Services Limitations for Fiscal Year 2016 of the Provincial Government of Cavite pursuant to Section 325 of the Local Government Code;

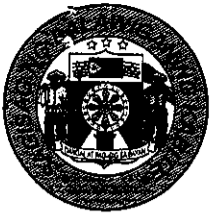


