PROVINCIAL ORDINANCE NO. 144

AN ORDINANCE TRANSFERRING THE SEAT OF PROVINCIAL GOVERNMENT OF CAVITE FROM THE PROVINCIAL CAPITOL COMPOUND IN TRECE MARTIRES CITY TO THE PROPOSED GOVERNMENT CENTER IN BRGY. LALAN 1ST, SILANG, CAVITE

WHEREAS, the current location of the Provincial Capitol in Trece Martires City, Cavite is no longer conducive for the growing necessity of the people of Cavite, due to traffic and limited space brought by the development and industrialization of the area;

WHEREAS, there is a need to relocate the seat of the Provincial Government of Cavite to a place that will be more accessible to Caviteños coming from all part of the province, and that will allow a construction of a structure reflective of the current stature of Cavite as one of the most progressive provinces in the country today;

WHEREAS, Section 11 of Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991, provides that when conditions and development in the local government unit concerned have significantly changed, the seat of government may be transferred to a better site taking into consideration of the geographical centrality, availability of transportation and communication facilities, development and economic progress, and other relevant consideration;

WHEREAS, Section 12 of the LGC, provides in part that provinces, cities and municipalities shall endeavor to establish a government center where offices, agencies or branches of the national government, local government units, or government-owned or -controlled corporations may, as far as practicable, be located;

WHEREAS, Resolution No. 198 ratified the Memorandum of Agreement with the Municipality of Silang for the co-development of the said government center;

WHEREAS, the Municipality of Silang is willing to host the Provincial Government in its transfer of government seat;

WHEREFORE, there is a need to transfer the seat of the Provincial Government of Cavite to Barangay Lalaan 1st, Silang, Cavite, to provide an appropriate and efficient service that every Caviteño deserves;

NOW THEREFORE, on the motion of Hon. Lara, duly seconded by Hon. Grepo and all the Sangguniang Panlalawigan Members present, be it enacted by the Sangguniang Panlalawigan in session duly assembled that:

Section 1. The seat of the Provincial Government of Cavite from the Provincial Capitol Compound in Trece Martires City is hereby transferred to the proposed government center in Brgy. Lalaan 1st, Silang, Cavite.

Section 2. This ordinance takes effect immediately.

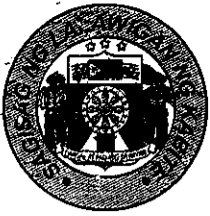


