PROVINCIAL ORDINANCE NO. 147

AN ORDINANCE DECLARING THE THIRD WEEK OF OCTOBER OF EVERY YEAR AS THE ATTENTION DEFICIT/HYPERACTIVITY DISORDER (AD/HD) AWARENESS WEEK IN THE PROVINCE OF CAVITE

WHEREAS, Article 2 Section 15 of the 1987 Philippine Constitution, provides in part that the State shall protect and promote the right to health of the people;

WHEREAS, Presidential Proclamation 472 signed by then President Gloria Macapagal-Arroyo, provides that the third week of October is declared as the National Attention Deficit/Hyperactivity Disorder Awareness Week;

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that the local government shall ensure and promote the general welfare of its constituents, to include among others, the promotion of health and welfare;

WHEREAS, AD/HD is a chronic brain disorder with social, academic and emotional impacts which can affect an estimated four (4) million Filipinos nationwide;

WHEREAS, early identification, intervention and support to AD/HD can make a big difference in the children's success to have a normal life;

NOW, THEREFORE, on the motion of Hon. Reyes, duly seconded by Hon. Grepo and all the Sangguniang Panlalawigan Members present, be it enacted by the Sangguniang Panlalawigan in session duly assembled that:

Section 1. Short Title. This ordinance shall be known and cited as "The Attention Deficit/Hyperactivity Disorder (AD/HD) Awareness Week in the Province of Cavite."

Section 2. Declaration of Policy. It is hereby declared the policy of the Provincial Government of Cavite to promote a supportive environment among communities to enable persons with AD/HD to live with dignity and enable them to function independently and contribute productively to society.

Section 3. Celebration. This yearly event shall be observed every third week of the month of October.

Section 4. Funding. For the effective implementation of this ordinance, the Provincial Governor of Cavite shall appropriate necessary funds to defray the expenses of this activity subject to availability of funds, and the usual rules on accounting and auditing.

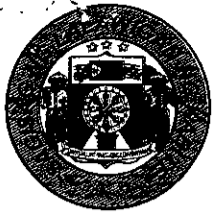
Section 5. Effectivity. This ordinance shall take effect immediately upon its approval.
