AN ORDINANCE DECLARING THE LAST WEEK OF OCTOBER OF EVERY YEAR AS FOOD SAFETY AWARENESS WEEK IN THE PROVINCE OF CAVITE

WHEREAS, food is considered as one of the most basic needs of a human being;

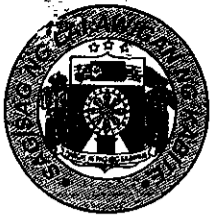
WHEREAS, being the primary commodity, measures shall be instituted to insure the safety of food from the time of its production, to preparation and consumption in order to protect the health and well-being of every individual especially the children;

WHEREAS, Section 16 of the Local Government Code of 1991 states that all Local Government Units shall exercise the powers necessary and those which are essential to the promotion of the general welfare of its inhabitants;

WHEREAS, Proclamation No. 160 signed into law by former President Joseph Ejercito Estrada declared the last week of October of every year as "Food Safety Awareness Week"

WHEREAS, there is a need to declare the last week of October as Cavite Food Safety Awareness Week to reinforce the importance and create awareness towards safe food handling among Caviteños;

NOW, THEREFORE, on the motion of Hon. Nato, duly seconded by Hon. Grepo and all the Sangguniang Panlalawigan Members present, be it enacted by the Sangguniang Panlalawigan in session duly assembled that:

Section 1. Short Title. This Ordinance shall be known and cited as the "Food Safety Awareness Week Ordinance in the Province of Cavite."

Section 2. Observance. The Food Safety Awareness Week shall be observed on the last week of October of every year with various programs and celebration.

Section 3. Purpose. This ordinance aims to heighten public awareness about proper food preparation practices, and adopt an integrated and comprehensive approach to health development.

Section 4. Coverage. This Ordinance shall cover the whole Province of Cavite.

Section 5. Implementation. The Provincial Government, the cities and municipalities, together with non-governmental organizations, shall lead the implementation of comprehensive public education and awareness program of food safety.

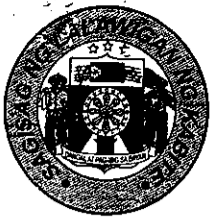
Section 6. Effectively Clause. This Ordinance shall take effect immediately after its approval.


