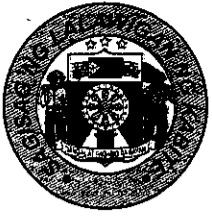
PROVINCIAL ORDINANCE NO. 156

AN ORDINANCE REVERTING THE VACANT POSITION OF ADMINISTRATIVE AIDE IV (DRIVER II), ITEM NO. PG 40 SALARY GRADE 4, IN THE OFFICE OF THE PROVINCIAL GOVERNOR, FROM PRIMARILY CONFIDENTIAL TO CAREER CLASSIFICATION

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan for review and consideration, is a letter from Hon. Jesus Crispin C. Remulla, Provincial Governor;

WHEREAS, the reversion of the aforementioned position is requested and is hereby in compliance with Memorandum Circular No. 12, s. 2011 issued by the Civil Service Commission, which states that *"positions in the Offices of the Provincial Governor, Provincial Vice Governor, City/Municipal Mayor/Vice Mayor or, Sangguniang Panlalawigan/Panlungsod/Bayan with position titles belonging to the career service, the duties of which do not require the highest degree of trust and confidence as shown in the description of duties and responsibilities, but were classified as primarily confidential under MC No. 22, s. 2007, shall be reverted to their career service classification"*;

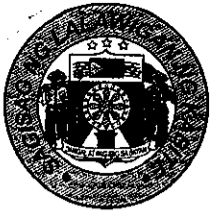
