**A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH (DOH) REGIONAL HEALTH OFFICE AND THE CARSIGMA DISTRICT HOSPITAL REGARDING THE IMPLEMENTATION OF THE MEDICAL ASSISTANCE PROGRAM FOR INDIGENTS SEEKING CONSULTATION, ADMITTANCE TO GOVERNMENT HOSPITALS, AND THE USE OF ITS HEALTH CARE FACILITIES**

**WHEREAS**, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Juanito Victor C. Remulla Jr., Provincial Governor;

**WHEREAS**, Section 15, Article II of the 1987 Philippine Constitution states that *"The State shall protect and promote the right to health of the people and instill health consciousness among them"*;

**WHEREAS**, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

**WHEREAS**, Section 16 of the same Act states in part that local government units shall promote health and safety and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, the DOH Regional Health Office provides financial help to indigents who seek assistance in paying consultation and admittance fees to government hospitals and other health care facilities;

**NOW, THEREFORE**, on motion of Hon. Lara and Hon. Nato, duly seconded by Hon. Grepo and all the members present, be it

**RESOLVED, AS IT IS HEREBY RESOLVED**, that Hon. Juanito Victor C. Remulla, Jr., Provincial Governor, be authorized, for and on behalf of the Provincial Government of Cavite, to enter into and sign the Memorandum of Agreement with the DOH Regional Health Office and CarSIGMA District Hospital regarding the implementation of the medical assistance program for indigents seeking consultation, admittance to government hospitals, and the use of its health care facilities.
