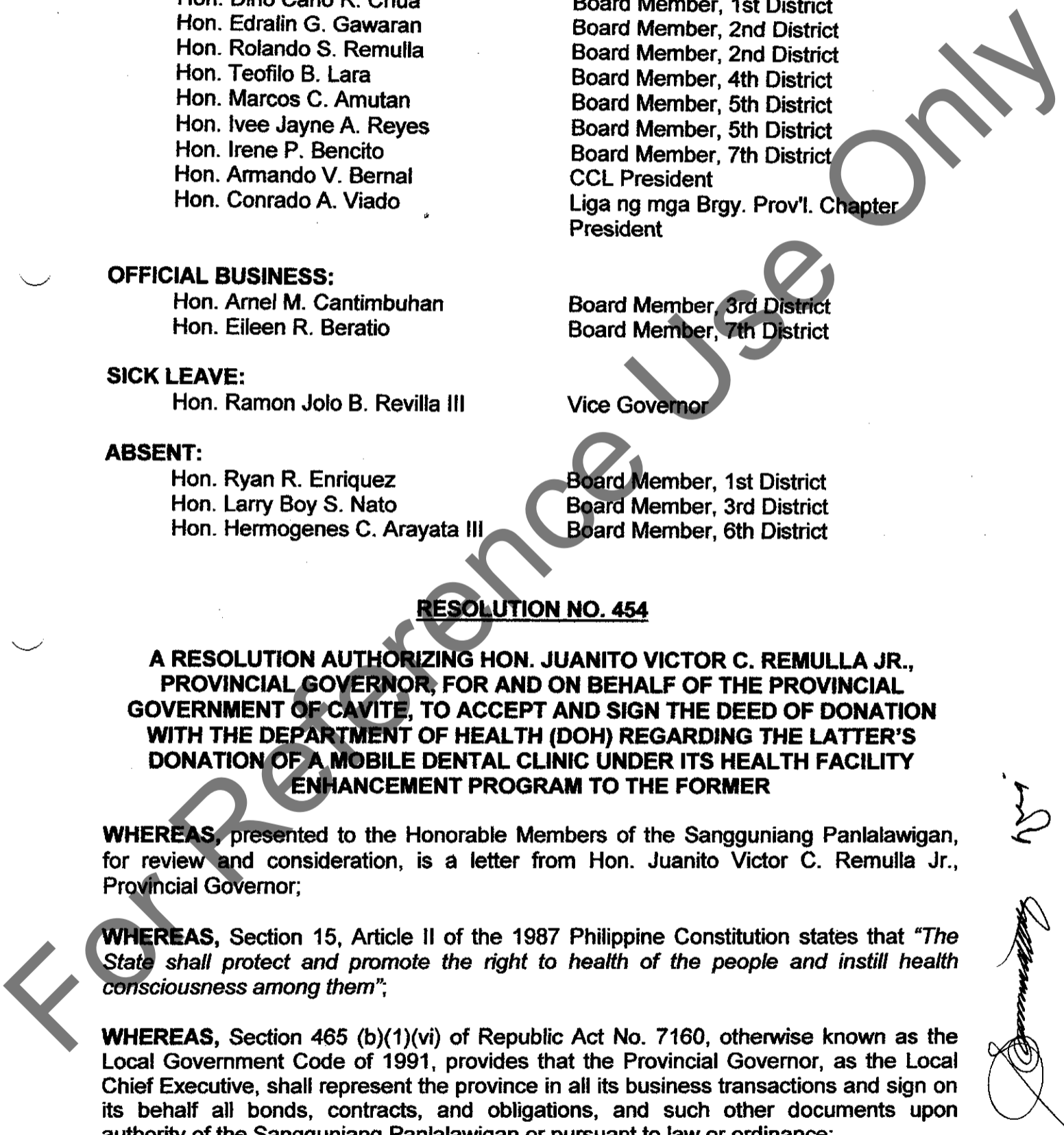

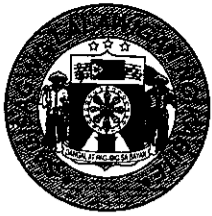
A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO ACCEPT AND SIGN THE DEED OF DONATION WITH THE DEPARTMENT OF HEALTH (DOH) REGARDING THE LATTER'S DONATION OF A MOBILE DENTAL CLINIC UNDER ITS HEALTH FACILITY ENHANCEMENT PROGRAM TO THE FORMER

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Juanito Victor C. Remulla Jr., Provincial Governor;

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution states that *"The State shall protect and promote the right to health of the people and instill health consciousness among them"*;

WHEREAS, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, the DOH implements the Health Facility Enhancement Program with the main goal of improving the delivery of basic, essentials, and as well as specialized health services;

WHEREAS, it was determined that there is only 1 government dentist for every 48,000 to 50,000 citizens, hence, the prevalence of dental diseases starting at childhood;

WHEREAS, as resolve to the lack of dentists, the DOH invests in the acquisition of mobile dental clinics and dental equipment to provide enhanced services and cover underserved cities and municipalities in the country;


NOW, THEREFORE, on motion of Hon. Amutan and Hon. Lara, duly seconded by Hon. Grepo and all the members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that Hon. Juanito Victor C. Remulla, Jr., Provincial Governor, be authorized, for and on behalf of the Provincial Government of Cavite, to accept and sign the Deed of Donation with the Department of Health regarding the latter's donation of a mobile dental clinic under its Health Facility Enhancement Program to the former.
