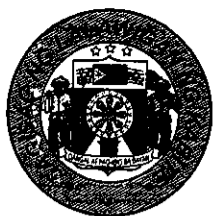
**RESOLUTION NO. 457**

**A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO ENTER INTO AND SIGN THE TERMS OF PARTNERSHIP WITH THE DEPARTMENT OF HEALTH (DOH)-REGION OFFICE IV FOR THE MANAGEMENT AND IMPLEMENTATION OF THE PROVINCE-WIDE INVESTMENT PROGRAM FOR HEALTH (PIPH)**

**WHEREAS,** presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Juanito Victor C. Remulla Jr., Provincial Governor;

**WHEREAS,** Section 15, Article II of the 1987 Philippine Constitution states that *"The State shall protect and promote the right to health of the people and instill health consciousness among them"*;

**WHEREAS,** Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;
