A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT WITH THE IGLESIA NI CRISTO (INC) TO ALLOW THE LATTER TO ENTER THE PROVINCIAL JAIL COMPOUND AND CONDUCT ACTIVITIES AND SERVICES TO ITS DETAINED MEMBERS

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Juanito Victor C. Remulla Jr., Provincial Governor;

WHEREAS, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, as of 27 January 2016, there is a total of 866 detainees in the Provincial Jail wherein 43 are members of the INC;

WHEREAS, the present facilities within the Provincial Jail compound are not sufficient to address the needs of the inmates, including the undertaking of rehabilitation and values-formation programs, activities, and services;

WHEREAS, both parties desire to improve the living conditions of the detainees in the Provincial Jail and promote their effective rehabilitation;

NOW, THEREFORE, on motion of Hon. Enriquez and Hon. Cantimbuhan, duly seconded by Hon. Mangubat and all the members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that Hon. Juanito Victor C. Remulla, Jr., Provincial Governor, be authorized, for and on behalf of the Provincial Government of Cavite, to enter into and sign the Memorandum of Agreement with the Iglesia ni Cristo to allow the latter to enter the Provincial Jail compound and conduct activities and services to its detained members.
