## **RESOLUTION NO. 460**

A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA, JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITÉ, TO PURCHASE A PARCEL OF LAND (1,000 SQUARE METERS) FOR THE ESTABLISHMENT OF A MULTI-PURPOSE HALL IN BARANGAY BALITE II, SILANG, CAVITE

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is a letter from Hon. Juanito Victor C. Remulla Jr., Provincial Governor;

WHEREAS, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, the land to be purchased is 1,000 square meters which is covered by Tax Declaration No. 18-006-00159, in the amount of One Thousand Pesos (Php1,000.00) per square meter or a total amount of One Million Pesos (Php1,000,000.00);
