WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is Committee Report No. 026-2016, submitted by Hon. Ivey Jayne A. Reyes, Chairperson, Committee on Finance, Budget, and Appropriations, pertaining to an ordinance from the Municipality of Naic, titled:

Ordinance No. 20-S-2015 – An Ordinance Enacting Supplemental Budget No. 03 Of The Municipality Of Naic For Calendar Year 2015

WHEREAS, the committee found out that the subject ordinance is consistent with the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and its Implementing Rules and Regulations;

WHEREAS, the submitted supplemental budget is hereby recommended to be operative in its entirety, effective on the date of its approval, subject to the following conditions:

1. The grant of the FY 2015 Productivity Enhancement Incentive (PEI) to government employees shall strictly be in accordance with the guidelines prescribed in Executive Order No. 181 dated May 15, 2015;
2. Disbursement of appropriation for Overtime Pay shall be subject to Budget Circular No. 10 dated March 29, 1996;

3. The disbursement of all other appropriations shall be subject to the usual accounting and auditing rules and regulations.

Compliance with all existing law, rules and regulations relative to the implementation of the within reviewed Supplemental Budget shall be the sole responsibility of the local government unit concerned.


NOW, THEREFORE, on motion of Hon. Reyes, duly seconded by Hon. Grepo and all the members present, be it
