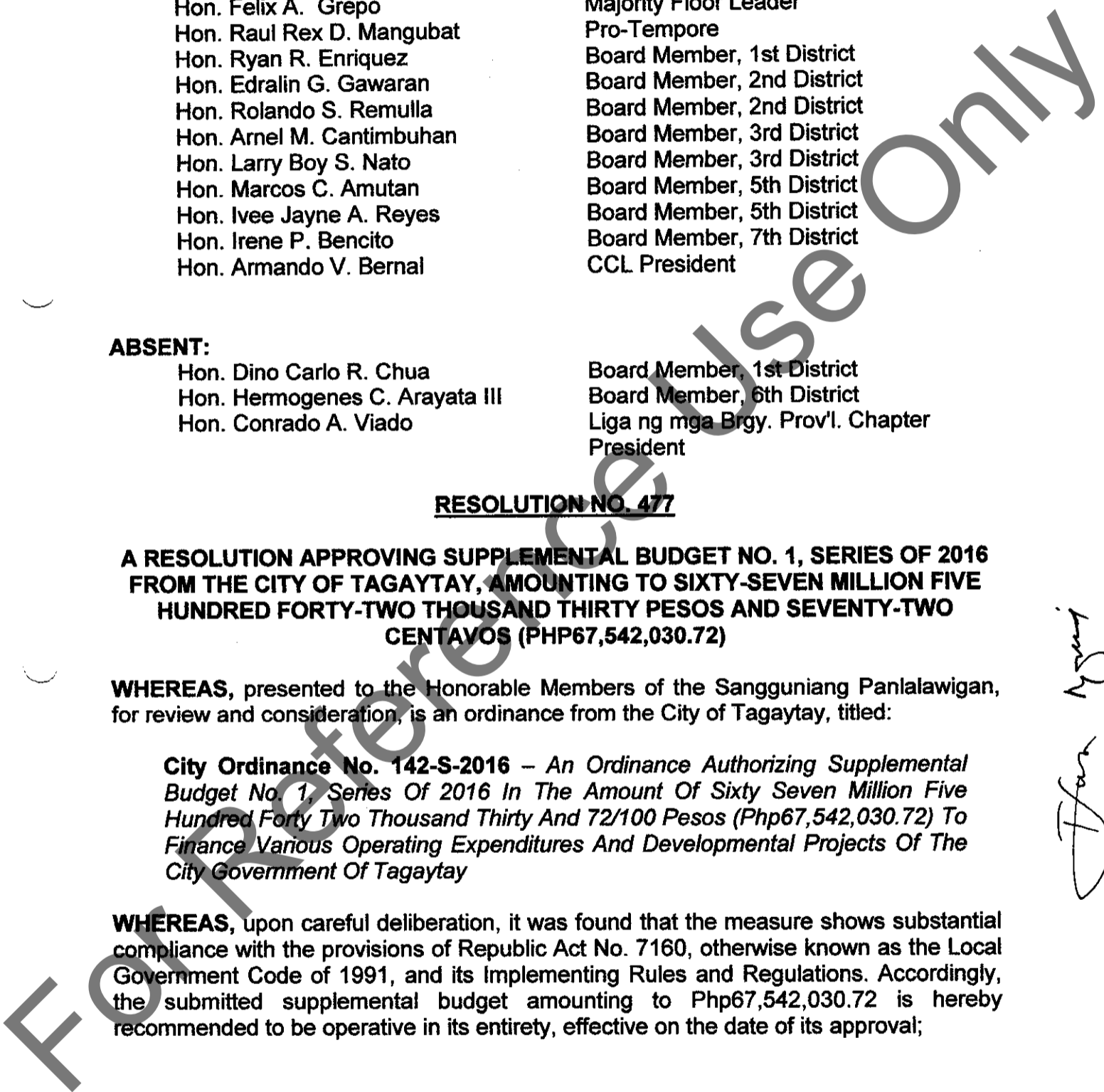

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is an ordinance from the City of Tagaytay, titled:
