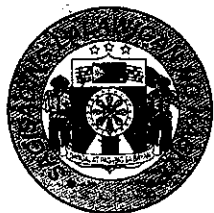
**RESOLUTION NO. 487**

**A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA, JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO SIGN THE MEMORANDUM OF UNDERSTANDING BETWEEN THE GENERAL EMILIO AGUINALDO HOSPITAL/KOREA PHILIPPINES FRIENDSHIP HOSPITAL AND THE MEDICAL SERVICES OF AMERICA, INC. FOR THE PROVISION OF CARDIO-PULMONARY SERVICES BY PROVIDING CARDIO-PULMONARY LIFE-SAVING VITAL EQUIPMENT FOR THE INTENSIVE CARE UNIT OF THE FORMER**

**WHEREAS**, presented to the Honorable Members of the Sangguniang Panlalawigan for review and consideration, is a letter from Hon. Juanito Victor C. Remulla, Jr., Provincial Governor;

**WHEREAS**, Section 465 (b)(1)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Provincial Governor, as the Local Chief Executive, shall represent the province in all its business transactions and sign on its behalf all bonds, contracts, and obligations, and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

**WHEREAS**, the cardio-pulmonary services should be provided sufficiently by hospitals to avoid compromise to a patient's life and to ensure that further complications will be evaded;

**WHEREAS**, an agreement was made that a Cardio-Pulmonary Life-Saving Vital Equipment will be provided by the Medical Services of America, Inc., in order to sustain state-of-the-art cardio-pulmonary services needed to provide by the General Emilio Aguinaldo Memorial Hospital/Korea Philippines Friendship Hospital;

**WHEREAS**, the said agreement was already reviewed and concluded to be in order by the Provincial Legal Officer;

**NOW, THEREFORE**, on motion of Hon. Lara and Hon. Nato, duly seconded by Hon. Grepo and all the members present, be it;

**RESOLVED, AS IT IS HEREBY RESOLVED**, Hon. Juanito Victor C. Remulla, Jr., Provincial Governor, be authorized, for and on behalf of the Provincial Government of Cavite, to enter into and sign the Memorandum of Understanding between the General Emilio Aguinaldo Memorial Hospital/Korea Philippines Friendship Hospital and the Medical Services of America Inc. for the provision of cardio-pulmonary services by providing Cardio-Pulmonary Life-Saving Vital Equipment for the intensive care unit of the former.
