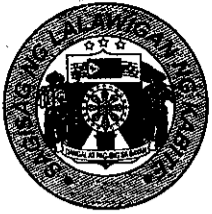
A RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 1, SERIES OF 2016 FROM THE CITY OF GENERAL TRIAS, AMOUNTING TO TWO HUNDRED THIRTY-FIVE MILLION FIVE HUNDRED TWELVE THOUSAND SEVEN HUNDRED EIGHTY PESOS (PHP235,512,780.00)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is an ordinance from the City of General Trias, titled:

City Ordinance (Appropriation) No. 16-03 – Appropriating The Sum Of Two Hundred Thirty Five Million Five Hundred Twelve Thousand Seven Hundred Eighty Pesos (Php 235,512,780.00) To Be Taken From: (A). Additional Internal Revenue Allotment (IRA) For 2016, (B). Surplus From Actual Income Of 2015, (C). Garbage Disposal Funds, And (D). Improvement Of Dumping Site Funds To Be Made Available As Supplemental Budget No. 01 For The Different Object Expenditures Of The Local Government Unit Of General Trias
