**A RESOLUTION AUTHORIZING HON. JUANITO VICTOR C. REMULLA, JR., PROVINCIAL GOVERNOR, FOR AND ON BEHALF OF THE PROVINCIAL GOVERNMENT OF CAVITE, TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE PROVINCIAL HEALTH OFFICE (PHO)/GENERAL EMILIO AGUINALDO MEMORIAL HOSPITAL (GEAMH)/KOREA-PHILIPPINES FRIENDSHIP PROJECT (KPPF) AND THE CARL AND CYRENE SIOMAI AND SIOPAO STAND REGARDING THE OPERATION OF A FOOD CART STORE AT GEAMH/KPPF**

**WHEREAS**, presented to the Honorable Members of the Sangguniang Panlalawigan for review and consideration, is a letter from Hon. Juanito Victor C. Remulla, Jr., Provincial Governor;
