A RESOLUTION URGING THE REPRESENTATIVES IN CONGRESS OF THE PROVINCE OF CAVITE TO SUPPORT THE KONKRETO AT AYOS NA LANSANGAN ANG DAAN TUNGO SA PANGKALAHATANG KAUNLARAN (KALSADA) PROGRAM OF THE NATIONAL GOVERNMENT

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan for review and consideration, is a letter from Hon. Juanito Victor C. Remulla, Jr., Provincial Governor;

WHEREAS, KALSADA is a national project of the Department of the Interior and Local Government (DILG) and the Department of Budget and Management (DBM) to fund local roads;

WHEREAS, as a result to the dialogue during the 7th General Assembly of the League of Provinces of the Philippines on 15 March 2016, the aforesaid program will be scaled-up in 2017 with a proposed budget of Thirty Nine Billion Pesos (Php39,000,000,000.00) from Six Billion Five Hundred Million Pesos (Php6,500,000,000.00) in 2016 which is included by the DBM in the proposed National Expenditure Program for 2017 to be endorsed to Congress for inclusion in the General Appropriations Act;
