RESOLUTION NO. 508

A RESOLUTION DESIGNATING THE CAÑAS RIVER AND THE MAALIMANGO RIVER AS A WATER QUALITY MANAGEMENT AREA (WQMA) IN THE PROVINCE OF CAVITE

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan for review and consideration, is a letter from Hon. Juanito Victor C. Remulla, Jr., Provincial Governor;

WHEREAS, Section 5 of Republic Act No. 9275, otherwise known as "The Philippine Clean Water Act of 2004", provides that the Department of Environment and Natural Resources (DENR), in coordination with National Water Resources Board (NWRB), shall designate certain areas as water quality management areas using appropriate physiographic units such as watershed, river basins or water resources regions. Said management areas shall have similar hydrological, hydrogeological, meteorological or geographic conditions which affect the physicochemical, biological and bacteriological reactions and diffusions of pollutants in the water bodies, or otherwise share common interest or face similar development programs, prospects or problems;

WHEREAS, Section 3 (i) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Local Government Units shall share with the national government the responsibility in the management and maintenance of ecological balance within their territorial jurisdiction, subject to the provisions of this Code and national policies;
