RESOLUTION NO. 510

A RESOLUTION APPROVING THE SUPPLEMENTAL BUDGET FROM THE MUNICIPALITY OF CARMONA, AMOUNTING TO THIRTY-SEVEN MILLION TWO HUNDRED NINETY-FOUR THOUSAND THREE HUNDRED FORTY-ONE PESOS AND FIFTY-SEVEN CENTAVOS (PHP37,294,341.57)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is Committee Report No. 050-2016, submitted by Hon. Ivey Jayne A. Reyes, Chairperson, Committee on Finance, Budget, and Appropriations, pertaining to an appropriation ordinance from the Municipality of Carmona, entitled:

Appropriation Ordinance No. 01-2016 – An Ordinance Enacting Supplemental Budget Amounting To Thirty-Seven Million Two Hundred Ninety-Four Thousand Three Hundred Forty-One Pesos And Fifty-Seven Centavos (Php37,294,341.57) To Be Sourced Out From Government Equity (Balance Beginning Of The Year) And Reversion Of Cash Gift Accounts And Further Approving And Authorizing The Implementation Of The First Tranche Compensation Adjustment For All Local Government Personnel Of The Municipality Of Carmona, Cavite

WHEREAS, upon careful deliberation, it was found that the measure shows substantial compliance with the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and its Implementing Rules and Regulations. Accordingly, the submitted supplemental budget amounting to Php37,294,341.57 is hereby recommended to be operative in its entirety, effective on the date of its approval, subject to the following conditions:

1. Utilization of savings certified available by the Municipal Treasurer shall be subject to the condition that the same remain free of any obligation or encumbrances and/or are still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriations were originally authorized;
2. That the grant of salary increase of municipal officials and employees, mid-year bonus and Productivity Enhancement Incentive shall strictly be in accordance with the provisions of Local Budget Circular No. 108 dated February 24, 2016 issued by the Department of Budget and Management; and
3. That the disbursement of all other appropriations shall be subject to the usual accounting and auditing rules and regulations.

Compliance with all existing laws, rules and regulations relative to the implementation of the within reviewed Supplemental Budget shall be the sole responsibility of the local government unit concerned.


NOW, THEREFORE, on motion of Hon. Reyes, duly seconded by Hon. Grepo and all the members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that the Supplemental Budget from the Municipality of Carmona, amounting to Thirty-Seven Million Two Hundred Ninety-Four Thousand Three Hundred Forty-One Pesos And Fifty-Seven Centavos (Php37,294,341.57), be approved.
