RESOLUTION NO. 519

A RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 2, SERIES OF 2016 FROM THE CITY OF BACOR, AMOUNTING TO ONE HUNDRED FIFTY-FIVE MILLION PESOS (PHP155,000,000.00)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is Committee Report No. 060-2016, submitted by Hon. Ivey Jayne A. Reyes, Chairperson, Committee on Finance, Budget, and Appropriations, pertaining to an ordinance from the City of Bacoor, entitled:

City Ordinance No. CO 24-S-2016 – An Ordinance Authorizing Supplemental Budget No. 2 Series Of 2016 Involving The Amount Of One Hundred Fifty-Five Million Pesos (Php155,000,000.00) For Current Operating Expenditures And Capital Outlay Of The City Government Of Bacoor For Fiscal Year 2016

WHEREAS, upon careful deliberation, it was found that the measure shows substantial compliance with the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and its Implementing Rules and Regulations. Accordingly, the submitted supplemental budget amounting to Php155,000,000.00 is hereby recommended to be operative in its entirety, effective on the date of its approval subject to the following conditions:

1. The grant of salary increase of city officials and employees, mid-year bonus and Productivity Enhancement Incentive indicated in the plantilla of personnel in various offices shall strictly be in accordance with the provisions of Local Budget Circular No. 108 dated February 24, 2016 issued by the Department of Budget and Management.

- The creation of the following positions shall be subject to Section 325(d) and (g) of Republic Act No. 7160, Section 4 of Local Budget Circular No. 53, and Section 3.0 of LBC No. 61 for proper classification of the position title and salary grades of the Items, and subject further to the minimum standards and guidelines prescribed by the Civil Service Commission pursuant to Section 76 of Republic Act No. 7160;

- The creation of Public Employment Service Office as a department and the positions of City Government Department Head I, City Government Asst. Dept. Head I and Labor and Employment Assistant shall be subject to approval of the Department of Budget and Management;
- Purchase of vehicle shall be subject to the provisions of Memorandum Circular No. 2013-47 dated June 3, 2013 issued by the Department of Interior and Local Government;
- The transfer from General Fund to Special Education Fund in the amount of P5,004,798.45 shall not be allowed for lack of legal basis;
- The disbursement of all other appropriations shall be subject to the usual accounting and auditing rules and regulations.

RESOLVED, AS IT IS HEREBY RESOLVED, that Supplemental Budget No. 2, Series of 2016 from the City of Bacoor, amounting to One Hundred Fifty-Five Million Pesos (Php155,000,000.00), be approved.
