A RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 2-S-2016 FROM THE MUNICIPALITY OF MAGALLANES, AMOUNTING TO ONE MILLION NINE HUNDRED SIXTY-TWO THOUSAND FIVE HUNDRED THIRTY PESOS AND TWENTY-SIX CENTAVOS (PHP1,962,530.26)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is Committee Report No. 097, submitted by Hon. Homer T. Saquilayan, Chairman, Committee on Finance, Budget, and Appropriations, pertaining to an ordinance from the Municipality of Magallanes, titled:

WHEREAS, the submitted supplemental budget amounting to Php1,962,530.26 is hereby recommended to be operative in its entirety, effective on the date of its approval, subject to the following conditions:

- That the utilization of savings jointly certified available by the Municipal Treasurer and Municipal Accountant shall be subject to the condition that the same remain free of any obligation or encumbrances and/or are still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriations were originally authorized;
- 2. That the salary step increment granted to elective officials shall strictly be in accordance with CSC-DBM Joint Circular No. 1, s. 2016 dated January 27, 2016;
- 3. That the disbursement of all appropriations shall be strictly subject to existing accounting and auditing rules and regulations.
- 4. That compliance with all existing laws, rules and regulations, relative to the implementation of the within reviewed Supplemental Budget No. 2 for CY 2016 shall be the sole responsibility of the local government unit concerned.

NOW, THEREFORE, on motion of Hon. Saquilayan, duly seconded by Hon. Gawaran and all the members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that Supplemental Budget No. 2-S-2016 from the Municipality of Magallanes, amounting to One Million Nine Hundred Sixty-Two Thousand Five Hundred Thirty Pesos And Twenty-Six Centavos (Php1,962,530.26), be approved.
