A RESOLUTION APPROVING SUPPLEMENTAL BUDGET NO. 2, SERIES OF 2016 FROM THE CITY OF TAGAYTAY, AMOUNTING TO TWENTY-NINE MILLION NINE HUNDRED NINETEEN THOUSAND SEVEN HUNDRED THIRTY-ONE PESOS AND FORTY-TWO CENTAVOS (PHP29,919,731.42)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is Committee Report No. 098, submitted by Hon. Homer T. Saquilayan, Chairman, Committee on Finance, Budget, and Appropriations, pertaining to an ordinance from the City of Tagaytay, titled:

City Ordinance No. 181-s-2016 — An Ordinance Authorizing Supplemental Budget No. 2, Series Of 2016 In The Amount Of Twenty-Nine Million, Nine Hundred Nineteen Thousand Seven Hundred Thirty-One And 42/100 (Php29,919,731.42) To Finance Various Operating Expenditures Of The City Government Of Tagaytay

**WHEREAS**, the submitted supplemental budget amounting to Php29,919,731.42 is hereby recommended to be operative in its entirety, provided however, that the disbursement of all appropriations enumerated therein shall be subject to the following conditions:

- That the utilization of excess income from collection certified available by the City Treasurer and City Accountant for supplemental appropriation are free from any obligation or encumbrance;
- That the appropriation for Donations shall not be utilized or applied for payment of salaries and/or other remunerations of personnel nor for religious or private purposes pursuant to Sec. 335 of the Local Government Code of 1991;
- 3. That the disbursement of all appropriations shall be strictly subject to existing accounting and auditing rules and regulations;
- 4. Compliance with all existing laws, rules and regulations relative to the implementation of the within reviewed Supplemental Budget shall be the sole responsibility of the local government unit concerned.

NOW, THEREFORE, on motion of Hon. Saquilayan, duly seconded by Hon. Gawaran and all the members present, be it

**RESOLVED, AS IT IS HEREBY RESOLVED,** that Supplemental Budget No. 2, Series of 2016 from the City of Tagaytay, amounting to Twenty-Nine Million Nine Hundred Nineteen Thousand Seven Hundred Thirty-One Pesos And Forty-Two Centavos (Php29,919,731.42), be approved.
