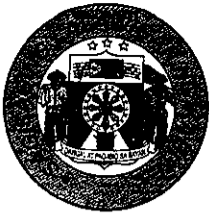
RESOLUTION NO. 583

A RESOLUTION APPROVING THE SUPPLEMENTAL APPROPRIATION FROM THE MUNICIPALITY OF CARMONA, AMOUNTING TO FORTY-TWO MILLION THREE HUNDRED SIXTY-THREE THOUSAND SIX HUNDRED FIFTY-TWO PESOS (PHP42,363,652.00)

WHEREAS, presented to the Honorable Members of the Sangguniang Panlalawigan, for review and consideration, is Committee Report No. 105, submitted by Hon. Homer T. Saquilayan, Chairman, Committee on Finance, Budget, and Appropriations, pertaining to an ordinance from the Municipality of Carmona, titled:

Appropriation Ordinance No. 03-2016 – An Ordinance Authorizing The Supplemental Appropriation In The Amount Of Forty Two Million Three Hundred Sixty Three Thousand Six Hundred Fifty Two Pesos (P42,363,652.00) To Be Used For The Programs/Projects And Activities (PPAs) Included In The Proposed Statement Of Supplemental Appropriation Thereby Modifying The 2016 Annual Investment Plan And Local Expenditure Program FY 2016 Of The Municipality Of Carmona, Cavite

WHEREAS, upon review of the Committee and the Provincial Budget Office, the ordinance is recommended for approval after the measure showed substantial compliance with the provisions of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and its Implementing Rules and Regulations;

WHEREAS, the submitted supplemental budget amounting to Php42,363,652.00 is hereby recommended to be operative in its entirety, effective on the date of its approval, provided however, that the disbursement of all appropriations enumerated therein shall be subject to the following conditions:

1. That the utilization of savings jointly certified available by the Municipal Treasurer and OIC Municipal Accountant shall be subject to the condition that the same remain free of any obligation or encumbrances and/or are still available after the satisfactory completion or the unavoidable discontinuance or abandonment of the work, activity or purpose for which the appropriations were originally authorized;
2. That the creation of position shall be subject to Sec. 325 (d) and (g) of RA 7160, Sec. 4 of Local Budget Circular No. 53 and Sec. 3.0 of LBC No. 61 for proper classification of the position title and salary grades of the Items and subject further to the minimum standards and guidelines prescribed by the Civil Service Commission pursuant to Section 76 of Republic Act No. 7160;
3. That the appropriation for Other Maintenance and Operating Expenses shall include only cost of services which cannot be classified under any account name. Likewise, the same shall not be used for payment of salaries and other remunerations of personnel nor for religious or private purposes pursuant to Section 335 of the Local Government Code of 1991;
4. That the disbursement of all appropriations shall be strictly subject to existing accounting and auditing rules and regulations;
5. That compliance with all existing laws, rules and regulations relative to the implementation of the within reviewed Supplemental Budget No. 2 for CY 2016 shall be the sole responsibility of the local government unit concerned.

NOW, THEREFORE, on motion of Hon. Saquilayan, duly seconded by Hon. Gawaran and all the members present, be it

RESOLVED, AS IT IS HEREBY RESOLVED, that the Supplemental Appropriation from the Municipality of Carmona, amounting to Forty-Two Million Three Hundred Sixty-Three Thousand Six Hundred Fifty-Two Pesos (Php42,363,652.00), be approved.
